## Terms & Conditions for Membership

1. Application form is non-transferable valid only for current financial year.
2. (a) Fulfilling the conditions of eligibility, submitting duly filled form with supporting documents and requisite fee shall not ensure the grant of membership of the club unless candidate is admitted to such membership by the Executive Committee and decision of committee is communicated to him by the authorised person of the club.  
(b) Any false declaration and suppression of any material information required in the application form shall be deemed to be disqualification and rejection of the application form and/or session of Membership.
3. Minimum age for the grant of club membership is 18 years. Applicant should submit age certificate in Support.
4. Applicant should be socially reputed, having good moral character and should be an Income Tax Payer (copy of PAN card required)
5. Only Dependent child of the existing Permanent / Life member is eligible of club membership after attaining of minimum age of 24 years, Application shall be considered in the General category and shall be charged accordingly. The decision of the executive committee shall be final and binding in case of granting club membership to the dependent.
6. In the application form, details of dependents viz name of spouse, children, their date of birth (with certificate), qualification, blood group etc along with three passport size photographs should be given. Incomplete application forms shall be liable to be rejected.
7. Application form at any stage of processing can be rejected without assigning any reason there to.
